
should consider the plight of these stranded residents of Great Nicobar and consider to schedule sailing of a ship for them to reach homes

## **MP Takes Stock of Major Water Projects Proposed for the Islands**

Mr. Kuldeep Rai Sharma, Member of Parliament, A & N Islands along with Mr. K Ganeshan, Ex-Chairperson, PBMC met Secretary, APWD and discussed major water projects proposed in the islands.

He informed the Secretary about the difficulties faced by the residents due to the water crisis in six Municipal Wards, particularly during the dry season. He also requested the Secretary, APWD for completing the repair works of pipelines damaged due to the Dairy Farm Culvert Project. The Secretary, APWD informed the MP that out of the two pipelines damaged at the culvert project site, repair work of one pipeline is already completed and repair work of another pipeline is under progress which will also be completed

Secretary APWD further informed the MP that once the work is completed residents will face no water problems. She further informed that work is progressing at a fast pace and is likely to completed soon.

On the proposed major projects, she informed that the submarine pipeline laving work in the Rutland water supply project between Phongi Balu at Chidiva Tapu and Rut Land will start shortly as experts from mainland are expected to arrive in the islands shortly. In the same manner, works for the Flat Bay water project will also commence soon as the team of experts have already submitted their final reports and obtained. been have

She also informed that directions have been issued to various Panchayats in the islands to undertake de-silting works of various water sources, including ring wells. Mr. Kuldeep Rai Sharma has requested the Secretary to expedite all the water projects so that the residents of the islands do not have to face water crisis in the summer months when the demand for water is more and supply is not sufficient.

### **Details of Movement by E-Pass Holders are now Being Recorded at Check Points**

Andaman and Nicobar Police has now started recording details of movement of all epass holders at various checkpoints across South Andaman. E-Pass or movement pass of everyone passing through the check posts are being strictly checked and the details are being noted.

Earlier many instances of misuse of E-Passes were reported and now A & N Police is strictly checking all details of the E-Pass including

the routes on which one is allowed to move Yesterday a case had come to light where a truck had reached Ponghy Chuang area of Port Blair without a valid E-Pass for sanitisation. The truck was later taken to the Police Station after the objection of the Ex-Councillor of the area.

District Magistrate, South Andaman has declared all villages under Little Andaman Tehsil as Containment Zone through order no. 759, issued on 16th June 2021. The orders have been issued after detection of a number of COVID-19 cases from the above mentioned areas.

Only essential activities shall be allowed in the containment zones. Strict perimeter control will be ensured and there shall be no movement of people in or out of the containment zone except for medical emergencies and for maintaining supply of essential goods and services. There shall be intensive house to house surveillance by surveillance teams formed for the purpose. Testing shall be carried out in containment zones as per prescribed protocol. Listing of contacts shall be carried out in respect of all persons found positive, along with their tracking, identification, quarantine and follow up of contacts for 14 days. 80% of contacts are to be traced in 72 hours. Surveillance of ILI/SARI cases shall be carried out in health facilities or outreach mobile units or through fever clinics in the buffer zones.

21 COVID positive cases were detected from Little Andaman when people were tested through RAT for travelling to Port Blair by M.V Kalighat. District Administration on 15 June 2021 had also collected samples for RT-PCR from Little Andaman which was transported to Port Blair through
