Sub:- Submission of representation to resolve the issues between the Students of DBRAIT, Dollygunj, Port Blair and the Management - reg.

Sir/ Madam,

With due respect, we would like to put forth few lines for your goodself kind consideration and necessary action please.

That the students of DBRAIT, Dollygunj, Port Blair studying in different trades had approached the Local Born Association and Andaman MOPLAH Service Organization, Port Blair regarding the Affiliation Issues of DBRAIT, Dollygunj, Port Blair from Pondicherry University. The issues raised by the Students are as follows:-

1. To withdraw all pending Court Cases before the Hon'ble High Court for affiliation to DBRAIT, Dollygunj, Port Blair from Pondicherry University. Due to the pending Court Case around 328 students are affected in getting their University Results. Further, it is to inform your goodself that Dr.Utpal Sharma, Principal DBRAIT, Dollygunj, Port Blair had also misguided the A&N Administration to file the case against the reputed Central University for not following such Provisional conditions. The arrogant and indiscipline behaviour of the Dr.Utpal Sharma, Principal

2. To fulfil all the 17 Norms and Affiliation conditions as pointed out by Pondicherry University which are in favour of the Welfare of the students. In this regard, it is to inform that since from the year 2009, the Pondicherry University regularly instructed the Authorities of DBRAIT, Dollygunj, Port Blair as well as A&N Administration to comply with the University Norms and Conditions at Par with the Degree Regulations of AICTE. But, Dr.Utpal Sharma, Principal DBRAIT, Dollygunj, Port Blair deliberately and intentionally defying those directions and instead of complying the conditions, Dr.Utpal Sharma convinced the A&N Administration and filed the case before the Hon'ble High Court Circuit Bench at Port Blair for his vested interest. Since, the conditions are barely minimum to uplift the standards of Engineering Higher Education in these Islands, hence these should be fulfilled.
3. That the Diploma Programs must be affiliated to the valid Board. MSBTE has its jurisdiction limited to Maharashtra State only and no Diploma/ Polytechnic Institute of any other State should be affiliated as per the MSBTE Act, 1997. Moreover, the Lateral entry students have been restricted by the Pondicherry University to appear in the Degree Examinations due to the affiliation issues.
4. That it is pertinent to mention here that from reliable sources it has been known that Dr.Utpal Sharma is interested to bring the DBRAIT, Dollygunj, Port Blair under the ambit of Deemed University. In this connection, it is to inform that no Deemed University for these Islands or any Deemed University status should be given to DBRAIT, Dollygunj, Port Blair.
5. That the students of DBRAIT, Dollygunj Port Blair who had joined the esteemed institution in the year 2020 and 2021 for the course of B.Tech Civil, Electronics and Computer Science have not been registered yet



under the Pondicherry University as such they are also not being allowed for the Semester Examination since last two years.


6. That the regular students of 2021 as well as the students who have taken Lateral entry admission after 2020 and 2021, the University Examination has not been conducted till date. Moreover, the aforesaid matter was neither informed to the parents nor the students by any Authority from DBRAIT, Dollygunj, Port Blair.
7. That in the event, if the examination is conducted by the Pondicherry University, the Examination should be in a Formal Manner i.e. as per the norms and conditions of Pondicherry University.
8. That at present also Dr.Utpal Sharma, Principal DBRAIT, Dollygunj, Port Blair, having full knowledge that the Pondicherry University withdraw the affiliation from the DBRAIT, Port Blair, is inviting admission applications forms of the students of these Islands under various trades of DBRAIT which is absolutely illegal as the DBRAIT, Dollygunj, Port Blair is not affiliated. Moreover, it is requested to the A&N Administration kindly do not put the students in dark and till the issues of Affiliation of DBRAIT, Dollygunj, Port Blair is solved, till then the new admissions to be kept on hold.

That it would be candid to mention here that if the Vice Chancellor, Pondicherry University visits these Islands, then a meeting should be convened in the presence of representatives Local Born Association and Andaman MOPLAH Service Organization and Student representatives of DBRAIT, Dollygunj, Port Blair to sort out all the issues for the better future of the students as there was no fault on the part of any of the students in the aforesaid matter.

In view of the above facts and circumstances stated herein above, it is therefore requested to kindly look into the matter and take immediate action to sort out all the issues relating to DBRAIT, Dollygunj, Port Blair for the better future of the students. It is further to inform your goodself that the Local Born
